

# Joseph's Fine Dining and Reception Facility

## **ROOM RENTAL**

**A charge of \$300.00 is due on the night of the event for the rental of the room.** This charge is for heating/cooling and lighting of room, as well as set-up, arrangement, and clean-up before and after your event. Decorating can commence the morning of your event. Arrangements can be made to decorate up to 24 hours in advance of your event, as long as the room is not already booked.

## **Wedding Date Deposit**

**A deposit of \$300.00** is due at the time of booking your reception. The deposit will be subtracted from your final bill at the end of your event. This is a guarantee for us that you will follow through with the event, and in case of cancellation, your deposit will be forfeited, without exceptions.

## **Guarantee**

You are required to notify Joseph's **10 days prior to your event** with the exact amount of attendees. Billing for the event will be based on the number given 10 days prior to the event. You will be charged for that number or whatever is greater, without exceptions. Food choices and arrangements for the bar on the night of your event, must be given 10 days prior to the event as well, to allow enough time for the selected items to be ordered.

## **Sales Tax and Gratuity**

**A 6.5% food tax and a 9 % liquor tax will be added to the final bill.** (Liquor tax is just for the Open Bar or Host Bar) There is a **mandatory 15% gratuity added to any party of 15 or more** for the food portion of your event. Bartenders are NOT included in the gratuity, so any added tips/gratuity for the bar staff would be done by you.

## **Liability**

Joseph's is not responsible for lost or damaged items brought on to Joseph's property. The client assumes all responsibility for any damage committed by the client or any guests of the client. Joseph's is not responsible for any vehicle damage or theft on property. This includes vehicles left over night on Joseph's property. The drinking age is 21 years of age. All guests under the age of 35 must be prepared to show proper identification. **No ID, No Alcohol- PERIOD.** Not only does Joseph's comply with local law enforcement and the State Law, regarding underage consumption, but we will notify law enforcement if any underage client or guest consumes alcohol given to them by an adult.

## **Things to Remember**

All children must remain in the reception area. NO CHILDREN allowed in the lounge area open to the public. No drinking allowed outside of the Joseph's Facility! No smoking allowed inside the Joseph's Facility. No outside food or beverage is allowed on Joseph's property. State Law prohibits this (only exception is wedding cake or cupcakes). **State Law does not allow any banquet food to leave the premises!** There are In-House DJs for rent. Decorating is encouraged, however, **no confetti or chocolate**, due to the fact that they are very difficult to remove from carpet. Candles are encouraged, however, they must be glass-enclosed or floating in water.

## **Cake Service**

There is a \$40.00 charge for Josephs to cut and serve the cake at your event. This includes plates and forks for all guests.

## **PUNCH**

Punch is available on the night of your event at your request.

## **Linen Service**

There is a \$3.00 charge per linen and 50 cents per cloth napkin. We can match the napkins to your wedding colors.

## **Bar Prices**

Domestic Bottles and rail drinks start at \$2.75 per serving

Pop is \$1.50 per serving.

Keg Beer starts at \$250.00 for a 16 gallon keg.

Wine starts at \$3.25 per serving. Wine can be purchased for \$15/bottle for house wine.

Champagne can be purchased for \$16.00 per bottle. The bride and groom receive a complimentary bottle of champagne on Joseph's!

Remember, there is a **9% liquor tax** on the final bill for the open (host) bar. There is no gratuity automatically added to the final bar bill. If you wish to tip the bar staff, you are responsible for that.

## **FINAL BILL**

We ask that the final bill be addressed the night of the event, preferably before 11 PM. Cash or check is an acceptable form of payment. **\*\*There is a 3 % additional charge on the final bill if a credit card is used for final bill!\*\*** (See Joseph's Mgmt. for Details)\*\*
